To consider and approve, the proposal for buy back of its fully paid up equity shares of the Company and the matters necessary and incidental thereto, in accordance with the applicable provisions of the Companies Act, 2013, including Rules framed thereunder, the Securities and Exchange Board of India (Buy-Back of Securities) Regulations, 2018, Listing Regulations, as amended, and other applicable laws.

Further, the Company hereby intimates that the Company will be hosting an earnings call with analysts and investors of the Company with respect to financial results for the half year and year ended March 31, 2026 in accordance with Regulations 30 and 46 read with Schedule III of the Listing Regulations. The said earnings call will be held on Friday, April 24, 2026 at 04:00 p.m. (I.S.T.) The invite is enclosed herewith.

The presentation, audio recording and transcript of the earnings conference call will be submitted to the stock exchange and will be uploaded on the website of the Company within the prescribed timelines in accordance with the provisions of the Listing Regulations.
